



**MEMORANDUM OF AGREEMENT
BETWEEN
KING MONGKUT'S UNIVERSITY OF TECHNOLOGY
NORTH BANGKOK, THAILAND
AND
INSTITUTE OF TECHNOLOGY AND HEALTH BALI
INDONESIA**

The President of King Mongkut's University of Technology North Bangkok (KMUTNB), Thailand, and the Rector of Institute of Technology and Health Bali (Institut Teknologi dan Kesehatan Bali – ITEKES Bali), Indonesia signed a Memorandum of Understanding (MOU) for Academic Cooperation. The MOU established the general conditions under which academic cooperation between the two institutions would take place, across a range of activities.

As provided in Clause 4 of the above mentioned MOU, this Memorandum of Agreement aims to formalize the details of a specific cooperative program between KMUTNB and ITEKES Bali.

1. Student Mobility

- (a) Short term study of two to four weeks by up to 10 students in specific courses accompanied by a staff, negotiated on a reciprocal basis between the authorized coordinators at each institution (as specified in Attachment A);
- (b) The study tours may include observation visits to hospital, public health center, and community agencies for supplemental learning without direct patient contact or any form of clinical practice;
- (c) Course requirements or reports may be required by the home institution to their students;
- (d) The home institution will be responsible for the selection of suitable student applicants for the mobility program and for arranging other academic schedules of their students at the home institution;
- (e) The students must pay the appropriate tuition and other fees in their home institution for the semester as regular students. The host institution must not charge any tuition or other fees to the inbound students;
- (f) Both institutions agree to provide accommodation (e.g. student dormitory / guest house) for students and academic staff participating in the exchange program.
- (g) Both institutions agree that the students will personally shoulder the cost of their food, return airplane ticket and operating expenses such as health/accident insurance.

- (h) Both institutions agree to provide local transportation for students and academic staff during academic visits (e.g. visits to hospital / public health center and community agencies).
 - (i) Accreditation/transfer credit of the academic course completed by a students during the period of study at the host university will be at the discretion of the students' home university.
2. Staff/Faculty Mobility
- (a) The designated staff/faculty who will accompany/oversee their respective students will provide expertise in mutually agreed courses through team teaching for 2-4 weeks; provide cultural orientation and identified seminars for the staff and students of the host institution for exchange of relevant information; and, initiate collaborative research activities;
 - (b) The visiting staff/faculty must closely coordinate with the authorized coordinators at each institution (as specified in Attachment A) for the implementation of specific activities;
 - (c) The home institution will be responsible for the selection of suitable staff/faculty applicants for the mobility program and for arranging other academic schedules of their staff/faculty at the home institution;
 - (d) The staff/faculty will receive their salaries and other benefits from their home institution, including budget for their travel expenses and health/accident insurance. The host university, on the other hand must provide accommodation to the visiting staff/faculty for the duration of the visit.
3. An evaluation of the student and staff mobility program will be done annually and to be facilitated by the authorized coordinators of both institutions.
4. The aim of this Memorandum of Agreement shall be to achieve a broad balance in the respective contributions benefits of the collaboration and this shall be subject to periodic review by both universities. .
5. This Agreement will take effect from the date of its signing and shall be valid for a period of five (5) years from that date unless sooner terminated, revoked or modified by mutual written agreement between the Parties, and may be extended by mutual written agreement.
6. Either Party may terminate the Agreement at any time during the term, by the provision of three months written notice to the other Party.

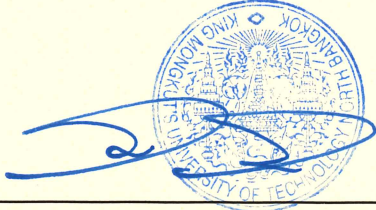

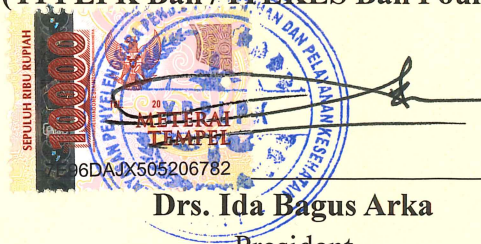
